General Information

Eligibility

Entry is limited to the first 48 two-person teams to enter in each division. A team shall be comprised of one male and one female. Entrants in the Husband & Wife division must be married to each other at the time of the Championship and are eligible for the Overall Championship. Entries are open to amateur golfers who are: (1) currently Associate Members of the MGA at the club from which they are playing, (2) whose club is a current member club of the MGA, and (3) the combined total of the 18 hole handicap index of the two players cannot exceed 28.4 at the time of entry. All entries are subject to approval or rejection at any time by the MGA Tournament Committee. **NOTE:** *Players do not need to be from the same club.*

Championship Format

Day 1: 18 holes, Four-Ball Stroke play

Day 2: 18 holes, Modified Chapman Stroke play

Starting Times

Mixed Division: Day 1 – AM; Day 2 – PM

Husband & Wife Division: Day 1 – PM; Day 2 – AM

NOTE: In the event conditions will not permit the total completion of the second round, the Committee reserves the right to cut the field after the first round to the low 16 teams plus ties in each division, and any team within four (4) strokes of the overall lead, for play in the second round. Also, in the event the tournament is not filled, the MGA reserves the right to modify the starting times.

Entry Deadline

Players are encouraged to enter MGA events online through the MGA website – www.mngolf.org. Entry forms will not be accepted before Monday, March 3, 2014, but must arrive no later than Monday, June 16, 2014, at the office of the Minnesota Golf Association, Inc., 6550 York Avenue South, Suite 211, Edina, MN 55435. The full entry fee of \$240 must accompany the entry form. **A separate check or money order must accompany each MGA championship entry.** Late or incomplete entries are not acceptable and will be returned. Entries submitted by telephone, e-mail or fax are not acceptable. Time limit for entries means time of receipt at MGA (not time of postmark). Entries with insufficient funds will be considered incomplete and will be withdrawn. The entrant is responsible for any fee incurred by the MGA for NSF checks and must pay such fees before entry in further MGA events is allowed.

Carts and Caddies

You are encouraged to bring your own caddie if you wish to do so. Carrying your bag and the use of a pull cart, including motorized, is permissible. Motorized riding carts are permitted during the Championship; however, the MGA feels the use of such carts is contrary to the spirit of the game. Therefore, motorized carts should be used only by contestants physically unable to walk the course. Only motorized carts provided by the host facility may be used. Contestants are responsible for paying the appropriate fee for the use of such carts prior to play each day.

Practice Rounds

Practice rounds are available for a fee at the discretion of the Host Facility.
