GENERAL INFORMATION

Eligibility

Entries are open to amateur golfers who are: (1) currently Associate Members of the MGA at the club from which they are playing and (2) whose club is a current member club of the MGA. All entries are subject to approval or rejection at any time by the MGA Tournament Committee. Teams can be comprised of men and/or women. **NOTE:** *Players do not need to be from the same club.*

Team Captain

Player #1 on the application will represent the team as the captain. The captain will be the team contact should the MGA need to contact the team for any reason. The captain will be responsible for dealing with any issues, if necessary.

Championship Format

A maximum of 44 teams will participate in the Championship on September 2-3, 2014. For the purpose of play, teams will be divided into two squads of two players. Players #1 & 2 (as listed on the application) will be Squad A, and Players #3 & 4 will be Squad B. Squads will play a Four-Ball, net, stroke play format with the score for each squad added together for a team total. Play is over 36 holes, with each team playing 18 holes at The Preserve on Tuesday, September 2, and 18 holes at The Pines on Wednesday, September 3. The Champion will be the team with the lowest total for 36 holes. A tie for the Championship will be broken by a matching of final round score cards using the USGA recommendation found in Appendix I. **NOTE:** *In the event conditions will not permit the total completion of the second round, the Committee reserves the right to cut the field after the first round to the low 12 teams plus ties, and any team within four (4) strokes of the overall lead, for play in the second round.*

Entry Deadline

Players are encouraged to enter MGA events online through the MGA website – www.mngolf.org. Entry forms will not be accepted before Monday, March 3, 2014, but must arrive no later than Tuesday, August 19, 2014, at the office of the Minnesota Golf Association, Inc., 6550 York Avenue South, Suite 211, Edina, MN 55435. Entry is on a first-come basis, and the full entry fee of \$520 must accompany entry form. **A separate check or money order must accompany each MGA championship entry.** Late or incomplete entries are not acceptable and will be returned. Entries submitted by telephone, e-mail or fax are not acceptable. Time limit for entries means time of receipt at MGA (not time of postmark). Entries with insufficient funds will be considered incomplete and will be withdrawn. The entrant is responsible for any fee incurred by the MGA for NSF checks and must pay such fees before entry in further MGA events is allowed.

Carts and Caddies

You are encouraged to bring your own caddie if desired. Carrying your bag and the use of a pull cart, including motorized, is permissible. Motorized riding carts are permitted during the Championship; however, the MGA feels the use of such carts is contrary to the spirit of the game. Therefore, motorized carts should be used only by contestants physically unable to walk the course. Only motorized carts provided by the host facility may be used. Contestants are responsible for paying the appropriate fee for the use of such carts prior to play each day.

Practice Rounds

Practice rounds are available at both courses at the player's expense. Contact Grand View Lodge or the golf shop of each course to arrange a practice round and for pricing.
