## **Notice to Competitors**

**Qualifiers and Playoffs:** The low 3 scores from **Forest Hills Golf Club** qualify for the Championship. In the event of a tie for the final qualifying place or either alternate position, **a hole-by-hole playoff will be held immediately following the completion of play.** 

**Practice Rounds:** Forest Hills Golf Club is a private golf facility with practice rounds available for \$25.00 + tax. Please call Brian Steinke at Forest Hills, 651-464-3097 ext 15, and identify yourself as a US Women's Amateur golfer.

<u>Distance Measuring Devices:</u> All distance measuring devices are <u>prohibited</u> at all USGA qualifying and championship events. Penalty for breach: **DISQUALIFICATION**.

**Footwear Policy:** As stated on the official entry form, *shoes with traditionally-designed spikes* (regardless of composition) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.** 

**Practice Range:** The practice range will be open one (1) hour before the first starting time (8:30am) on the morning of the qualifying.

**Food and Beverage:** There will be food and beverage service available during the qualifying.

**Starting Times:** There will no change in the starting times established by the Committee other than by decision of the Committee due to weather conditions.

**Dress Code:** Shirts must have collars; <u>denim pants and jeans are not allowed</u>. Players and caddies must be neat in appearance with respect to clothing and personal grooming. The Committee will decide whether this requirement has been met. Dress code applies to caddies as well as players. Players will be held responsible for the appearance of their caddies.

<u>Caddies and Carts:</u> There will not be caddies available during this qualifying. You may bring your own caddie if you wish to use one, or you may carry your own bag or use a non-motorized walking cart. Players must not ride on any form of transportation during a stipulated round unless authorized by the Committee. Spectators will **NOT** be allowed to rent carts.

<u>Pace of Play:</u> The MGA Pace of Play policy will be in effect. You should make yourself familiar with it in advance of the qualifying.

**<u>Directions:</u>** Directions to the host club may be found on Forest Hills's website.

<u>Course Set-Up:</u> In order that you may play from the appropriate tees during your practice round, it is anticipated the golf courses will be set up as listed below. However, the Committee reserves the right to alter this set-up without notice.
